CHILD SUPPORT AND THE PARENTAL RESPONSIBILITY ACT

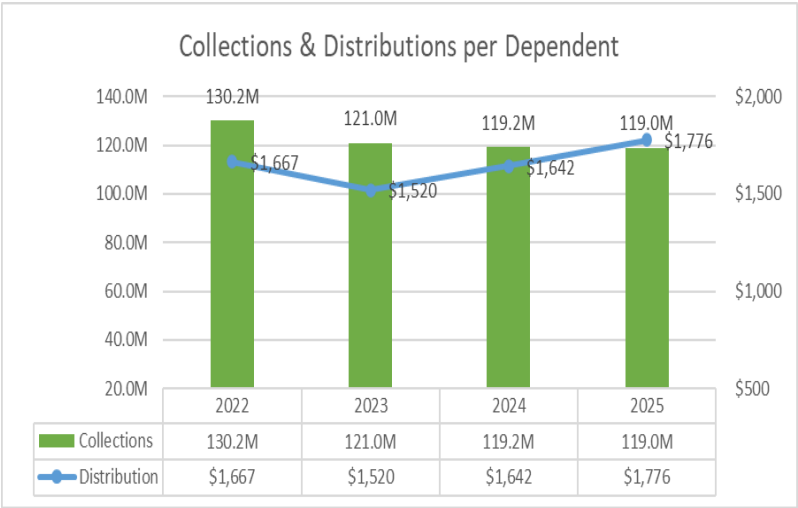
The Health Care Authority (HCA) - Child Support Services Division (CSSD) plays a very important role in the implementation of the Parental Responsibility Act (PRA) which has been in effect since July 1, 1995, through State Statute, § 40-5A-1 et seq., NMSA 1978.

The purpose of the PRA is to require parents to pay down, or in some instances, eliminate child support delinquencies and arrearages or participate in modernization initiatives in order to be issued, maintain or renew a driver's, professional, and/or recreational license. There are currently sixty-three (63) New Mexico state entities that issue licenses as defined by the PRA. HCA-CSSD works with all entities to bring parents back into compliance with their child support obligation and ensure children are financially supported. Studies have shown that the consistent collection of child support has a positive effect on familial relationships, involvement by the non-custodial parent in the child's life, the child's academic achievements, and cognitive development in young children.

In 2018, the HCA-CSSD began a concerted effort to implement national best practices and modernization initiatives to positively impact the families and children it serves. The HCA-CSSD is continuing to modernize and has made strong gains in better serving families. Some of these accomplishments include changing payment distribution and disbursement rules to get more money to current and former families on assistance; changing child support guidelines to allow for right-sized court orders based on the current economy and on ability to pay; and incorporating a self-support reserve to consider the subsistence needs of parents when determining child support obligations. The main goal in all these efforts is to ensure children get the consistent monthly financial support they need to grow up happy and healthy, while helping parents avoid falling behind on child support payments thus avoiding delinquencies and large arrearage balances. The graph to the right demonstrates how distributions per dependent/child are trending upward resulting in reliable payments.

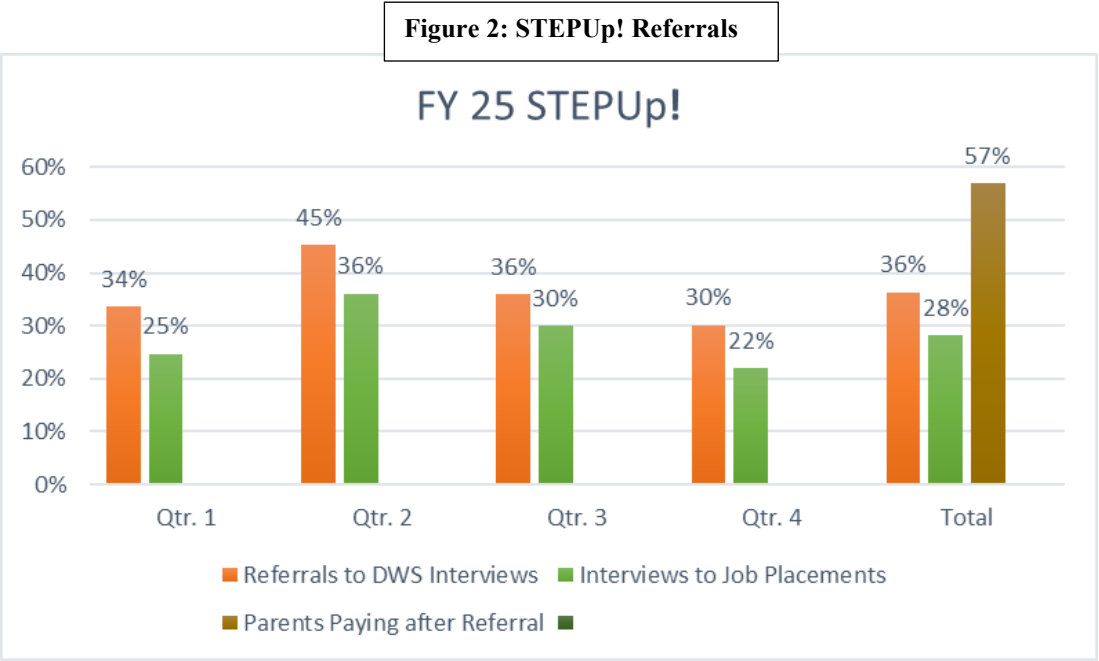
The PRA is just one of the programs that has benefited from modernization initiatives. In 2020, the HCA-CSSD implemented the Supporting, Training, and Employing Parents Up! (STEPUp!) program, which benefits non-custodial parents (NCPs) whose licenses have been or are in jeopardy of being suspended due to child support delinquency. The HCA-CSSD refers un-employed or underemployed NCPs to the Department of Workforce Solutions (DWS) to assist them with job development and job opportunities, with the goal of gaining employment and being placed on wage withholding for more consistent payments. By complying with the referral to the STEPUp! program, the NCPs are provided with a Certificate of Compliance (CoC) in order to get licenses re-issued or stop suspension by the licensing agency. Successful compliance with the referral to

the STEPUp! program is offered to non-custodial parents in lieu of making a lump sum payment to obtain the CoC.

The STEPUp! program allows an HCA-CSSD customer to meet with a DWS Career Consultant for assistance in obtaining employment and/or addressing barriers to finding employment. In October 2023, the Application Programming Interface (API) for the Child Support Enforcement System (CSES) went live which allows the HCA-CSSD staff to send automatic referrals to DWS for the STEPUp! program, resulting in a more efficient process. STEPUp! has seen successful referrals that are resulting in job placements and parents making payments after referral to the program.



THE PARENTAL RESPONSIBILITY ACT - PROCESS AND PROGRESS

The PRA states that, upon receiving appropriate notice, a parent will comply with subpoenas and warrants relating to child support and parentage. Under the PRA, due process protections for the parent are outlined and require the board that is denying the application or renewal of the license to

provide written notice of the grounds for the denial and the right to an administrative hearing. ¹

A PRA requirement of the HCA-CSSD (§ 40-5A-1 et seq., NMSA 1978) is annual reporting to the Governor and the NM State Legislature on the progress of child support enforcement measures. These measures include:

- 1) the number of obligors certified by the division as delinquent.
- 2) the number of obligors who also were licensees or applicants subject to the provisions of the PRA.
- 3) the number of licenses suspended or revoked by each board and the number of new licenses and renewals that were delayed or denied by each board.
- 4) the number of licenses and renewals that were granted following an applicant’s compliance with a judgment and order for support; and
- 5) the cost incurred for the year in the enforcement of the PRA.

The data for those measures for the reporting period of November 1, 2024, to October 31, 2025, are:

- 1. The number of monthly delinquent obligors certified by the division is noted in the following table:

- 2. The number of obligors who also were licensees or applicants subject to the provisions of the PRA: **144,529**
- 3. The number of licenses that were suspended or revoked by each board, and the number of new licenses and renewals that were delayed or denied by each board: **14,811**
- 4. The number of licenses and renewals that were granted following an applicant’s compliance with a judgment and order for support: **2,564**
- 5. The number of administrative hearings conducted by the licensing entities: **0**
- 6. The cost incurred by the licensing agencies in the enforcement of the PRA: **\$29,395**

Figure 3: Total Lump Sum Payment Amounts Collected for PRA Compliance

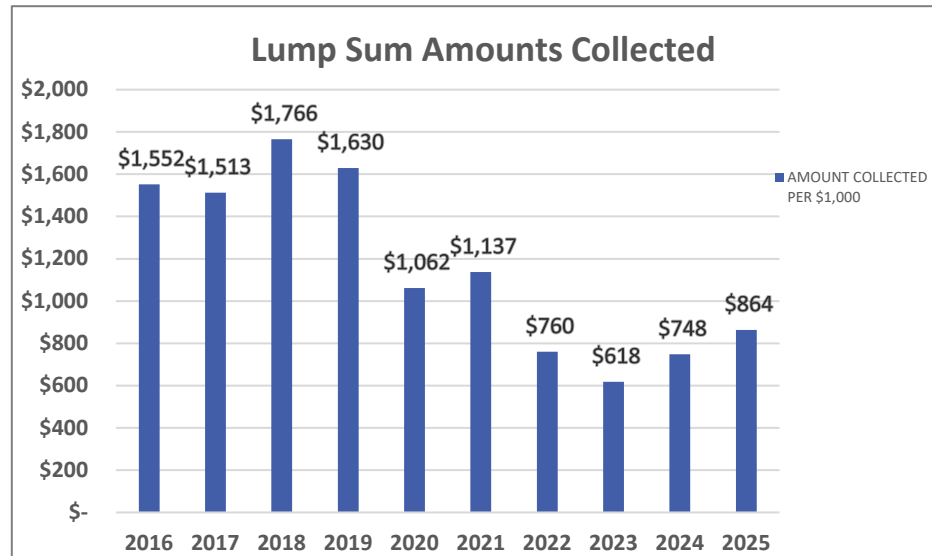
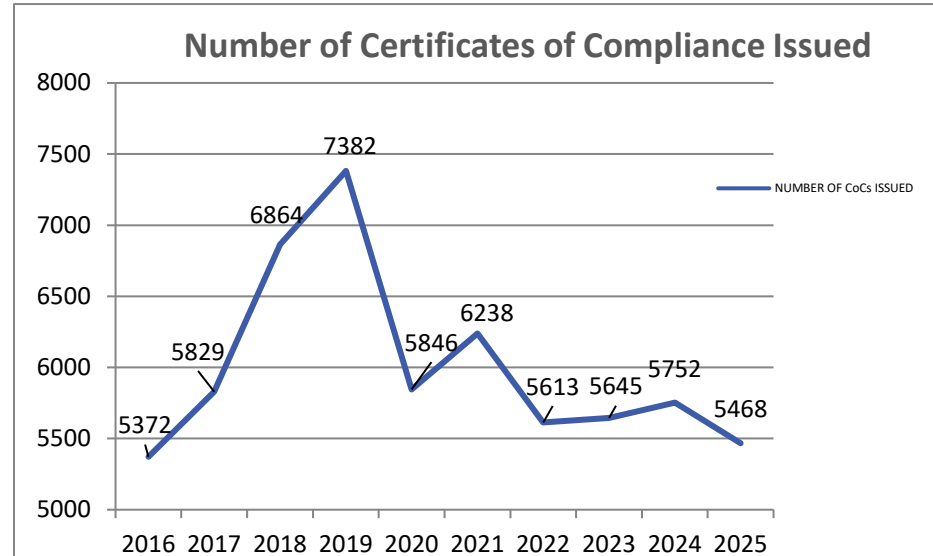


Figure 4: Total Number of Certificates of Compliance Issued



The HCA-CSSD collected a total of \$864,253.00 in lump-sum payments from PRA compliance. This is an increase in lump-sum payments from 2024 of \$748,390.00. The number of referrals to licensing entities and collections from lump-sum payments has decreased over time due, in part, to the STEPUp! program referrals that assist NCPs with job development and job opportunities to get them back on track to meeting their monthly child support obligations rather than simply paying a lump sum payment to get their license back. The HCA-CSSD certified a monthly average of 12,415 delinquent obligors for the current review period and issued 5,468 CoC's this year. The itemization of the amounts collected by the HCA-CSSD is noted in Table #2.

Currently, the licensing entities report to the HCA-CSSD both on a monthly and annual basis on the work they have performed to comply with the PRA. The work of the licensing entities for the reporting period from November 1, 2024, to October 31, 2025, is reflected in Table #3.

SUMMARY

Since the inception of the 1995 Parental Responsibility Act and the License Suspension Program managed by the Child Support Services Division much has changed. The Child Support Program is always working to improve the License Suspension Program as an important enforcement tool. One of the goals for 2026 is to see improved compliance from the licensing entities under the PRA.

Most notable is the opportunity to provide non-custodial parents who are having a difficult time making their monthly obligations due to unemployment or under-employment the opportunity for job development and/or job placement through the STEPUp! Program, a collaboration with the Department of Workforce Solutions. Before this program, NCPs had to come up with a lump sum payment to get their license(s) back, and without employment, most NCPs found that step difficult to accomplish, resulting in delinquency and an inability to meet the Child Support program's requirements, but most importantly responsibility to their children. The STEPUp! referral has resulted in fewer lump sum collections, however, the Child Support Program is seeing improvement in other performance measures, such as current support collections, which are the monthly obligations on which the custodial parent and the child can rely.
