Interested Parties:

The New Mexico Health Care Authority (HCA), Medical Assistance Division (MAD) is providing notice on plans to submit a State Plan Amendment (SPA) request to the Centers for Medicare & Medicaid Services (CMS) to increase rates within the Family Infant Toddler (FIT) program for specific services provided on or after July 1, 2025.

These changes are being made as a result of the Early Childhood Education and Care Department (ECECD) receiving an appropriation of \$10,000,000 from the SFY25 State Legislature to increase rates for FIT Program services funded under State and Medicaid funds. These services are provided under the Early Periodic Screening Diagnostic and Treatment (EPSDT) Special Rehabilitation section. The State General Fund match will be paid through the ECECD.

The estimated financial impact is \$3,487,723.21 in federal funds for FFY25 and \$10,480,715.48 in federal funds for FFY26.
