RE: Tribal Notification to Request Advice and Comments Letter 25-15: Family Infant Toddler (FIT) Program Rate Increases.

Dear Tribal Leadership, Indian Health Service, Tribal Health Providers, and Other Interested Parties:

Seeking advice and comments from New Mexico's Indian Nations, Tribes, Pueblos and their health care providers is an important component of the government-to-government relationship with the State of New Mexico. In accordance with the New Mexico Health Care Authority's (HCA) Tribal Notification to Request Advice and Comments process, this letter is to inform you that the HCA, through the Medical Assistance Division (MAD), is accepting comments until 5:00 p.m. Mountain Time (MT) **July 25, 2025,** regarding a State Plan Amendment for Family Infant Toddler (FIT) Program Rate Increases.

Effective July 1, 2025, HCA's MAD is increasing rates for specific services under the FIT program as a result of the Early Childhood Education and Care Department (ECECD) receiving an appropriation of \$10,000,000 from the SFY25 State Legislature to increase rates for FIT Program services funded under State and Medicaid funds. These services are provided under the Early Periodic Screening Diagnostic and Treatment (EPSDT) Special Rehabilitation section. The State General Fund match will be paid through the ECECD.

The estimated total financial impact is \$3,487,723.21 in federal funds for FFY25 and \$10,480,715.48 in federal funds for FFY26.
