# **Land Acknowledgment by Natalie Rivera**

Approval of Agenda- Jackie Nielsen motioned to approve the agenda Paul Jenkins seconded the motion, the motion passed. Athena Huckaby motioned to add the Access to Buep. Jacqueline Nielsen shares about *Provider Listening Sessions* that will be held throughout the Four Corners of the state and then one in Central NM. These sessions will be geared toward Administrative Burden; getting feedback from providers on things that may be troubling you as providers such as administrative burden. Those who are not providers are still welcome to attend. BHSD is largely trying to focus on riding as much administrative burden on the providers side as well as on the BHSD side.

# Athena Huckaby, Access to Buprenorphine ASAM Recommendation

Athena presented to the ASAM Committee about the shortages around NM of Buprenorphine and how that is affecting New Mexicans who rely on their prescription for it. Just as a Diabetic may be reliant on their insulin, those prescribed to Buprenorphine are very much so reliant on their prescription in order to maintain their sobriety. Athena presented her presentation on the issues around Access to Buprenorphine, and the struggles pharmacies and providers are seeing around all of NM. ASAM voted for the recommendation that was made, for it to be brought to the BHPC to now be voted on here.

The Purpose of the proposed recommendation is to:

A. Address statewide barriers to pharmacies stocking adequate amounts of Buprenorphine, an evidence-based medication for Opioid Use Disorder.

B. Increase access to and retention in OUD treatment with Buprenorphine., thereby mitigating the heightened Risk of Fatal and non-fatal overdose among individuals recently released from incarceration, detoxification, inpatient treatment, and hospital settings.

\*It is recommended that the NM Gov. issue an executive order to ensure pharmacies can access sufficient quantities of buprenorphine to provide timely access to this life saving medication.

⇒ Paul Jenkins would like to make a motion to approve this recommendation, Stacey Keener seconds the motion, the motion carries.

# Turquoise Care

The Medicaid Managed Care name has changed from Centennial Care 2.0 to Turquoise Care and their benefit package will also be changing:

- The change to Turquoise Care went into effect on July 1<sup>st</sup>.
- As of July 1<sup>st,</sup> Western Sky Community Care will no longer be a Medicaid Managed Care Organization.
- As of July 1<sup>st</sup>, 2024 there are 4 MCO's:

Blue Cross Blue Shield of NM

Molina Healthcare of NM

Presbyterian Health Plan

United Healthcare Community Plan of NM

#### New Benefits Under Medicaid

- Continuous eligibility for children up to age six (started 1/1/24)
- Expanding Access to supportive Housing
- Addition of Chiropractic Services
- Additional Community Benefit Slots
- Expansion of the home visiting benefit for new mothers

## Turquoise Care & Children in State Custody (CISC)

- ⇒ Presbyterian Healthcare selected as the MCO to serve and meet the complex needs of most Children in State Custody.
- ⇒ Presbyterian Healthcare will provide services designed to improve the health outcomes and experiences of children and their families/caregivers.
- ⇒ Native American Children in state custody have their choice of any MCO.

## Blue Cross Blue Shield Presentation

#### CISC-

- BCBS has identified 33 members who are identified as Children in State Custody and Native American.
- BCBS has transitioned all CISC members to Presbyterian.

### Comprehensive Addiction and Recovery Act (CARA Program)-

- CARA Members are provided care coordination through its Full Delegation Model while providing oversight.
- The CARA program helps mothers and babies while they're in the NICU, and then follow them through that entire 1<sup>st</sup> year of life, making sure that they have the resources and the supports that they need.

#### Value Added Services:

- Friends and Family Circle- For parents/caregivers that are caring for family members
  with complex needs that struggle to do basic routine things like go to the store, movie
  or a restaurant.
  - -\$50 Walmart gift card a day for up to 10 days.
  - -Eligible Population Adults, Children, adolescents with complex health needs. Both Medical and Medical Expansion Populations.
  - -Caregiver Thank you Package
- Afterschool or Youth Activities- Targets members under 18 years old to pay for after school or sports activities. Up to \$50 per youth.
- **Infant Diapers** Available for pregnant members and new moms. Infant diapers are available for the first month from birth.

#### • Resource Toolkit

-Targets justice involved members and members experiencing homelessness. A "tool kit" notebook will contain both pre- identified statewide and national resource listings, and space to add personalized notes and resources. This will include preprinted resource information on the first several pages, such as the NMCAL, Unity and support, food banks, housing, etc.
