SUBJECT: USING TAXONOMY WITH THE NATIONAL PROVIDER IDENTIFIER (NPI) AND DEADLINES

I. SUMMARY OF PREVIOUS INFORMATION

Below is a summary of the previous supplement (Number 07-01) sent to providers:

- **Use of the NPI number** – Use of the NPI number will become mandatory for all healthcare providers in May, 2007. Providers who participate in SALUD! Managed Care and the Statewide Entity (SE) through ValueOptions of New Mexico must also be aware of the instructions and dates from each MCO and comply with those instructions.
- **New paper claim forms are required** – Federal government workgroups have designed new paper forms that accommodate NPI and taxonomy. Electronic 837 claim formats already accommodate NPI and taxonomy, but may still require changes on the part of the provider to use those fields appropriately.
- **All healthcare providers must apply for an for an NPI number** – This can be done online at <https://nppes.cms.hhs.gov>.
- **The provider must register their NPI numbers with ACS** – Go to the ACS web portal at <https://nmmedicaid.acs-inc.com>.

- **Non-healthcare providers may be exempt** – Only “atypical providers” (non-healthcare providers) may continue to file claims using their Medicaid provider ID numbers. Atypical providers must still use the new claim forms. Atypical providers include personal care option (PCO) providers, handivans, taxis, and meals and lodging providers. Some home and community based service (HCBS) waiver providers may also be atypical. (See “Waiver Providers”, below.) Schools and behavioral health providers are considered healthcare providers and must obtain NPI numbers.
- **Waiver provider information** – If a HCBS waiver provider only renders administrative services such as helping coordinate non-medical services, supports living arrangements (assisted, family, independent, supported, and environmental modifications), supplies home maker, respite or transportation services, the provider is “atypical” and will not need an NPI number. Generally, however, a HCBS waiver provider will need to apply for and use an NPI, particularly if any of their services are provided by a licensed healthcare provider such as an RN, an LPN, a therapist, etc.
- **Practitioners must “share” their NPI number when ordering a service** – When providers order services, prescribe drugs, admit patients to hospitals, make referrals, etc., they must provide their NPI number to the lab, pharmacy, hospital, or other providers because in many instances the provider rendering the ordered or prescribed service or item must have the practitioner’s NPI to file their own claim.
- **Group provider NPI information** – Providers at one location who form an “entity” such as a group, corporation, or other organization are able to obtain an NPI number for the “entity”. If payment is to be made to any business entity other than the individual provider, there must be separate NPI’s for the practitioners and the entity.
- **Each hospital and nursing facility must have an NPI number** – A corporation with multiple locations cannot use one NPI when each facility must be certified or licensed individually.
- **Each pharmacy and most business entities such as medical supply companies must have an NPI number for each location** – A chain or corporation with different business locations cannot use one NPI.
- **Multiple types of service under the same business** – If a professional services provider (that is, not a hospital or nursing facility) renders multiple types of service under the same business address and the same federal tax ID, the provider may choose to use just one NPI number because the provider’s “taxonomy” on the claim form will direct ACS to the appropriate provider to pay.
- **ACS website** – Go to the ACS web portal at <http://nmmedicaid.acs-inc.com> and click on "What's New" for information.

II. CRITICAL DATES AND NEW CLAIM FORMS

MAY 4, 2007 (Friday) – Paper claims received by ACS after this date must be the new claim forms that include blocks for provider taxonomy. The date the claim is received by ACS, not the date of mailing or post mark, is used to determine if a claim must be submitted on the new format.

On the new claim forms, the provider may use the NPI and taxonomy or may temporarily continue to submit the Medicaid provider ID number on the new forms as long as any claim ACS receives on or after May 23, 2007, has the NPI and taxonomy. Beginning Saturday, May 5, 2007, all paper claims must be one of the following:

- The 1500 format must be a red original CMS 1500 form (08/05 version) that includes fields for the NPI and taxonomy. The NPI and taxonomy must be completed for the billing provider as well as the rendering providers identified on the claim lines.
- The UB format must be a red original UB-04 form version that includes fields for the NPI numbers and taxonomy. The NPI and taxonomy must be completed for the billing provider identified on the claim. Identify the attending physician with the NPI and taxonomy.
- The dental claim format must be the ADA 2006 form that includes fields for the NPI and taxonomy. Knowing there are issues with dental providers obtaining red copies of the dental claim form, the new dental claim form will be accepted even if it is not a red form until the issue is resolved. However, we can assure dental providers that the ADA form is available in a red version. The form number is J404. Providers have to ask for form J404, not J400.
- The pharmacy claim format must be the Universal Drug Claim Form issued by the NCPDP that includes positions for the pharmacy NPI and taxonomy and NPI for the prescriber.

These requirements apply to all resubmitted claims and claims submitted for adjustments or re-consideration with correspondence. When a red form is required, the form cannot be a photocopied or otherwise duplicated form. Otherwise, the form will be returned to the provider.

MAY 17, 2007 (Thursday) – Electronic claims received by ACS after this date must have the NPI number and provider taxonomy. Beginning Friday, May 18, 2007, all electronic claims sent to ACS must meet the new requirements for NPI and taxonomy. Providers using PayerPath must also complete their claims with NPI numbers and taxonomy when submitted after May 17, 2007.

Precautionary Measures – Providers billing electronically are encouraged to put their Medicaid provider ID number in the appropriate fields in addition to providing their NPI number, using the appropriate qualifiers to distinguish between the two. This may be useful if there are claims processing problems which cannot be resolved without using the Medicaid provider ID.

III. USE OF TAXONOMY

Taxonomy – Taxonomy is a 10 digit number that enables providers to indicate their type of practice and specialty on a claim form. Use of taxonomy and the NPI is mandatory on healthcare claims.

- ACS will use the NPI number and the taxonomy as reported on the claim form to determine the Medicaid provider ID number of the provider to whom payment is to be made.
- Taxonomy is required on the claim when the NPI is used for the billing, rendering, and attending providers. Providers must state the taxonomy when registering for the NPI number. However, the provider is not restricted to using this same taxonomy when filing a claim if the provider has other types of claims and business that are best described by a different taxonomy
- Taxonomy will be used by ACS to locate the appropriate Medicaid provider ID number when the provider has one ID number for two or more lines of business. For example, if a home health agency also has a hospice Medicaid provider ID number and a private duty nursing number and the provider chooses to apply for only one NPI, different taxonomies are used by the provider to indicate when the claim is for home health, hospice, or private duty nursing.

Selecting Taxonomy for a Claim – Attached to this document are three tables which may be useful in selecting the taxonomy to use when filing claims.

Table I	Taxonomy (Non-physician)
Table II	Physician Taxonomy by Specialties
Table III	Taxonomy for Behavioral Health (Non-physician)

The list does not contain all the taxonomy codes but may be useful for providers in the following ways:

- For some providers there may not be an apparent preferable taxonomy but, rather, there may be several different possibilities from which to choose. This list may be used by providers to find the taxonomy the Medical Assistance Program recommends.
- HCBS waiver providers, when using an NPI number, must use the taxonomy 174400000X on a waiver claim and on a case management assessment claim for pre-eligibility assessment services. The taxonomy 174400000X must not be used on a non-waiver claim. Instead, the appropriate taxonomy for the non-waiver provider type must be used on a non-waiver claim. This distinction is very important in order for claims to be processed accurately.
- Hospital PPS exempt units must use the psych unit or rehab unit taxonomy to distinguish the unit from their acute care facility.

- Hospitals must use the hospital taxonomy for both their inpatient and outpatient departments.
- IHS hospitals do not have a special IHS taxonomy and therefore will use the acute care hospital taxonomy. There is a special taxonomy for an IHS pharmacy.
- Personal care option providers are “atypical” and so do not need to use NPI or taxonomy unless they are part of a health care provider, in which case they must use the taxonomy 3747P1801X.
- Pharmacy providers who do not have a separate DME/Medical Supply provider number who are submitting 1500 claims for medical supplies can still use the pharmacy taxonomy even if the claim is not a pharmacy claim.
- Physicians may use Table II to locate the taxonomy for their specialty. It is included as a convenience to providers. However, a physician may use any physician taxonomy which appropriately describes his or her specialty.
- Radiology facility taxonomy is confusing. A radiology facility may choose the taxonomy from the list which best describes the facility.
- Table III, the Behavior Health Provider taxonomy is also included as a convenience to providers. The BH taxonomy choices available do not generally reflect NM licensing categories or provider education levels. The list attached may be helpful when a provider needs to locate a BH provider taxonomy which closely corresponds to NM Medicaid provider types.

IV. USE OF LOCATION ZIP CODE

When an individual provider has more than one Medicaid provider ID number in order to be paid at more than one gross receipts tax rate, special procedures apply.

If the additional Medicaid provider ID numbers are for a facility or a group practice, it is possible for the provider to request different NPI’s for the various physical locations which should then be registered appropriately with ACS.

If it is not possible for the provider to obtain different NPI numbers for each location, the best alternative for a provider may be to work with the NM Taxation and Revenue Department to see if the business qualifies for one tax rate. Refer to the publication FYI 200 at <http://www.tax.state.nm.us/pubs/fyi200.pdf> page 3, on the NM Taxation and Revenue Department web site or call a NM Taxation and Revenue District Office.

If the above alternatives are not possible, the billing provider zip code on the claim must be the zip code for the physical location which matches the Medicaid provider ID number for that location. For example, if an individual provider were an optometrist who has individual

Medicaid provider ID numbers for practices in Santa Fe and Taos but only one NPI for both locations, the optometrist's claim must contain the NPI, taxonomy, and the zip code for either the Santa Fe or Taos location, depending on which location the service took place. ACS will then associate the NPI and zip code with the correct Medicaid provider ID number and make payment at the correct tax rate.

When the multiple Medicaid provider ID numbers are for locations that are individually certified or licensed, such as hospitals and nursing facilities, the Medical Assistance Division expects the provider to have a different NPI for each location.

V. ADDITIONAL ASSISTANCE

Technical Detail for Paper Claim Formats

NPI and Taxonomy Form Locators (FL): UB-04

- The billing provider NPI must be placed in FL 56. The billing provider's taxonomy code must be placed in FL 81a, b, c, or d. There are two fields on each line of FL 81. The first field is for the two-digit qualifier 'B3' which identifies the next form field as a taxonomy code. The next field must contain the billing provider's taxonomy code.
- For inpatient claims, the attending provider's NPI must be placed in FL 76 in the first un-shaded field on the first line. The second un-shaded field of FL 76 is for qualifier 'B3' which will indicate the following field contains a taxonomy code.
- The "operating provider" NPI may be placed in FL 77 (first un-shaded box). This is not a required field.
- The "other provider" NPIs can be placed in FL 78 and 79 (first un-shaded box of each field). These are not required fields.

NPI and Taxonomy Locator Fields (FL): CMS-1500:

- The billing provider NPI must be placed in FL 33a. The billing provider's taxonomy code must be placed in FL 33b with a preceding two-digit qualifier 'ZZ' (no spaces between values).
- The rendering provider NPI must be placed in FL 24J (un-shaded) of each valid service line. The servicing provider's taxonomy code on the CMS-1500 must be placed in FL 24J (shaded) with the corresponding qualifier 'ZZ' placed in FL 24I (shaded) when an NPI is populated in FL 24J.
- The referring provider NPI may be placed in FL 17b. The taxonomy is optional for NM Medicaid submissions but may be placed in FL 17a with the qualifier 'ZZ' in first box.

- The service facility NPI must be placed in FL 32a when any valid service line contains a place of service equal to 21, 22, 23, 31, 32, 51, or 54. The taxonomy is optional for NM Medicaid submissions but may be placed in FL 32b with the appropriate preceding two-digit qualifier 'ZZ' (no spaces between values).

Check List

- Register for NPI
- Inform ACS of NPI number using website
- Prepare systems to (1) use new paper claim forms when billing on paper; and (2) report NPI, taxonomy, and zip code on paper and electronic claim forms
- Ask questions on special situations
- Develop the capability to bill electronically to minimize problems

TABLE 1

NON-PHYSICIAN TAXONOMY TABLE

This "Non-Physician Taxonomy Table" is MAD's suggestion of the taxonomy to use based on the Medicaid provider type. It is most useful for provider types for which there may not be a clear taxonomy choice.

When a provider type is marked “atypical”, the provider does not have to use an NPI number nor report taxonomy unless part of a health care organization for which NPI and taxonomy is required.
