#### V. BACKGROUND SUMMARY

The New Mexico Health Care Authority (HCA) Register Volume 48, Register 18, dated May 20, 2025, issued the proposed New Mexico Administrative Code (NMAC) 8.200.400, Medicaid Eligibility, General Recipient Rules, 8.249.400, Refugee Medical Assistance (RMA) Program, Recipient Requirements, and 8.249.600, Refugee Medical Assistance (RMA) Program, Benefit Description.

Section 9-8-6 NMSA 1978, authorizes the Department Secretary to promulgate rules and regulations that may be necessary to carry out the duties of the Department and its divisions.

A public hearing was held on June 20, 2025, to receive public comments and testimony on these proposed rules. The HCA received one comment on the proposed changes. The commentor was opposed to the rule change as the reduction from twelve months to four months for health care

access could impact immigrants with disabilities. As the reduction in coverage is a federal requirement, the HCA is proceeding with the rule changes as proposed.
