## FREE AND HEALTHY FOOD FOR NEW MEXICANS!

The New Mexico Health Care Authority supports local food banks and food pantries serving the public through the Emergency Food Assistance Program (TEFAP).

The program provides nutritious foods at no cost to low-income households while supporting United States agriculture producers.

### HOW DO I QUALIFY?

You qualify if:

- Your household already receives SNAP, FDIPIR, WIC, or CSFP; **OR**
- If you are a New Mexico resident AND Fit within the TEFAP Income Guidelines



### HOW DO I APPLY?

- Contact your regional food bank for TEFAP distribution sites (see below).
- You will complete an application at the distribution site.

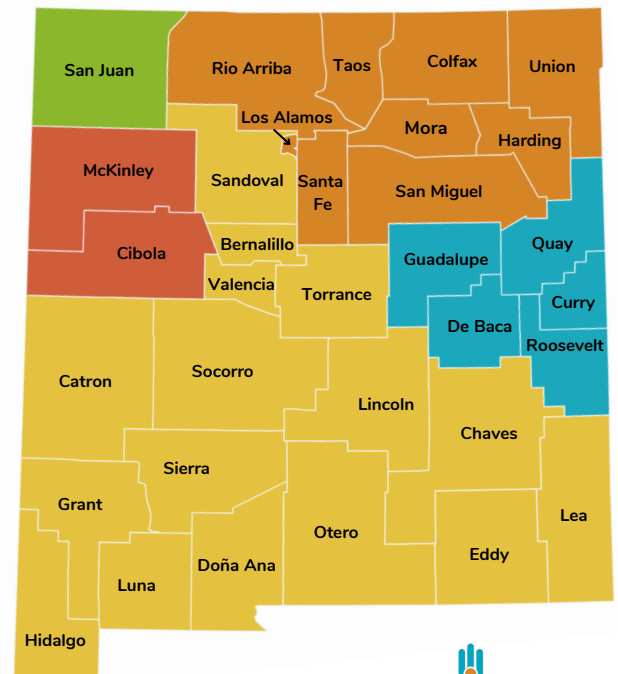
