RE: Tribal Notification to Request Advice and Comments Letter 25-01: NM's Quality Strategy December 2024 Revision Draft

Dear Tribal Leadership, Indian Health Service, Tribal Health Providers, and Other Interested Parties:

Seeking advice and comments from New Mexico's Indian Nations, Tribes, Pueblos and their health care providers is an important component of the government-to-government relationship with the State of New Mexico. In accordance with the New Mexico Health Care Authority's (HCA's) Tribal Notification to Request Advice and Comments process, this letter is to inform you that HCA, through the Medical Assistance Division (MAD), is accepting written comments until **5:00 p.m., Mountain Time (MT) on February 21, 2025**, regarding proposed amendments to New Mexico's Medicaid Managed Care Program, Quality Strategy December 2024 Revision Draft.

As required by the Code of Federal Regulations (CFR), the Quality Strategy must be reviewed and updated as needed, but no less than once every 3 years. The goal of the Quality Strategy is to ensure that New Mexico's Managed Care Program continues to drive towards improving healthcare service delivery and outcomes. Through established standards and a variety of mechanisms, the Quality Strategy will serve as the State's blueprint for monitoring and assessing the Managed Care Organizations, holding them accountable for improving outcomes. HCA is revising the Quality Strategy with updated initiatives outlined in NM's Turquoise Care 1115 Waiver Demonstration approved by CMS, in alignment with CFR requirements.
